Security Code?

The card security code is a unique three or four-digit number printed on your debit/credit card. This number is not embossed on the card and hence is not printed on receipts- making it difficult for anyone other than the genuine cardholder to know it. Some card issuers refer to this number as the 'Card Security Code' others as the 'personal security code' and others as the 'Card Verification Value'.



Some cards, many UK-issued cards for example, have a three-digit number printed at the top of the signature strip on the reverse of the card.



Others, American Express cards for example, have a four-digit number printed on the front of the card, above the account number.


